## **SECTION 4) FIRST-AID MEASURES**

#### Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. Get medical advice/attention if exposed, feel unwell (headache, nausea, drowsiness etc.) or are concerned.

# **Skin Contact**

Rinse/wash with lukewarm, gently flowing water and mild soap for 5 minutes or until product is removed. If skin irritation occurs or you feel unwell: Get medical advice/attention.

# **Eye Contact**

If irritation occurs, cautiously rinse eyes with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelids open. If eye irritation persists: Get medical advice/attention.

# Ingestion

### **Notes**

High velocity injection of grease under the skin may result in serious injury. If left untreated, the affected area is subject to infection, disfigurement, lack of blood circulation and may require amputation. When dispensed by high-pressure equipment, this material can

easily penetrate the skin and leave a bloodless puncture wound. Material injected into a finger can be deposited into the palm of the hand and in rare occasions up to the elbow. # SECTION 5) FIRE-FIGHTING MEASURES

## Suitable Extinguishing Media

Dry chemical, foam, carbon dioxide, water spray or fog is recommended. Water spray is recommended to cool or protect exposed materials or structures. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam. Water or foam may cause frothing. If leak or spill has not ignited, use water spray to cool the containers and to provide protection for personnel attempting to stop the leak.

# **SECTION 6) ACCIDENTAL RELEASE MEASURES**

# **Emergency Procedure**

Immediately turn off or isolate any source of ignition. Keep unnecessary people away; isolate hazard area and deny entry. Do not touch or walk through spilled material. Clean up immediately. Contain spill. Wipe up or add suitable absorbent, non-combustible, inert material such as sand, sawdust, etc. to spill area and shovel into appropriate container for disposal. Local authorities should be advised immediately if required or if significant spillages cannot be contained.

Ventilate area.

#### Recommended equipment

Positive pressure, full-facepiece self-contained breathing apparatus (SCBA), or positive pressure supplied air respirator with escape SCBA (NIOSH approved).

#### **Personal Precautions**

Avoid breathing vapor or mist. Avoid contact with skin, eye or clothing. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing.

#### General

Wash hands after use.

Do not get in eyes, on skin or on clothing.

Do not breathe vapors or mists.

Use good personal hygiene practices.

Eating, drinking and smoking in work areas is prohibited.

Remove contaminated clothing and protective equipment before entering eating areas.

#### **Ventilation Requirements**

Use only with adequate ventilation to control air contaminants to their exposure limits. The use of local ventilation is recommended to control emissions near the source.

#### **Storage Room Requirements**

Keep container(s) tightly closed and properly labeled. Store in cool, dry, well-ventilated areas away from heat, direct sunlight, strong oxidizers and any incompatibilities. Store in approved containers and protect against physical damage. Keep containers securely sealed when not in use. Indoor storage should meet OSHA standards and appropriate fire codes. Containers that have been opened must be carefully resealed to prevent leakage. Empty containers retain residue and may be dangerous.

Minimum feasible handling temperature should be maintained. Periods of exposure to high temperature should be minimized. Water contamination should be avoided.

# SECTION 8) EXPOSURE CONTROLS/PERSONAL PROTECTION

#### Eye protection

Wear eye protection with side shields or goggles. Wear indirect-vent, impact and splash resistant goggles when working with liquids. If additional protection is needed for entire face, use in combination with a face shield.

# Skin protection

Use of gloves approved to relevant standards made from the following materials may provide suitable chemical protection: PVC, neoprene or nitrile rubber gloves. Suitability and durability of a glove is dependent on usage, e.g. frequency and duration of contact, chemical resistance of glove material, glove thickness, dexterity. Always seek advice from glove suppliers. Contaminated gloves should be replaced. Use of an apron and over- boots of chemically impervious materials such as neoprene or nitrile rubber is recommended to avoid skin sensitization. The type of protective equipment must be selected according to the concentration and amount of the dangerous substance at the specific workplace.

#### Respiratory protection

If engineering controls do not maintain airborne concentrations to a level which is adequate to protect worker, a respiratory protection program that meets or is equivalent to OSHA 29 CFR 1910.134 and ANSI Z88.2 should be followed. 
